DEFINITION OF MEMBERSHIP CATEGORIES

GENERAL MEMBERS:

Membership in this category is open to:

- American companies with branches, agents, or representative offices in Egypt.
- Egyptian companies with American equity.
- Egyptian companies or individuals with significant business relationships with the U.S., and registered Egyptian agents of American companies.
- U.S. citizens residing in Egypt who have significant business or professional relationships with the U.S.

Note: General members have voting privileges.

ASSOCIATE RESIDENT MEMBERS:

Membership in this category is open to:

- Egyptian companies that are not presently doing business with the U.S. but wish to do so.
- **Multinational** companies with branches in at least three other countries besides Egypt and the U.S.
- **Young Entrepreneurs** who serve as majority owner and operate or bear principal responsibility for operating a small business, and who have a track record of two years or less, and who are under the age of 35 when applying for membership.
- **Public and Diplomatic Organizations:** this type of association is open to public organizations, diplomatic missions and multilateral institutions.

Note: Associate Resident members do not have voting privileges.

ASSOCIATE NON-RESIDENT MEMBERS:

Membership in this category is open to:

- American companies or individuals that have significant business relations with Egypt and do not qualify to be General Members.
- **International Non-Resident** category is open to institutions of any nationality other than U.S. that have significant business relations with Egypt but do not have a presence in Egypt. (*Residents of any country other than the U.S.*)

Note: Associate Non-Resident members do not have voting privileges.

NOT-FOR-PROFIT ORGANIZATIONS:

Membership in this category is open to organizations that have significant relationship with Egypt and the U.S. and which are organized for charitable, educational or eleemosynary purposes and not for profit.

Note: Not-for-Profit organization members do not have voting privileges.

AFFILIATE MEMBERS:

Membership in this category is open to individual staff members of companies that are already members of the Chamber.

Note: Individual Affiliate members do not have voting privileges.
